Retired Officers and employees who have opted for the Medical Insurance Scheme are advised to visit the website of Heritage Health Insurance TPA Pvt Ltd at the link <u>http://heritagehealthtpa.net</u> and use E-CARD generation facility to generate their individual health cards by inserting their respective Employee ID.Employee ID for all Retired Officers and employees are their respective EPF No (New).Those who have not provided their NEW EPF No may try their old EPF No in the following manner : OLD EPF Establishment code + OLD EPF No in four digit.EPF No with single/double/triple digit may be preceded by "0"s to make it four digit( For example- **227050015** for Old establishment code **22705** and Old EPF No **15**).Hard copy of the cards will be delivered through the Branches from where Insurance premium was paid.
