Sub: Consent form for payment of Commutation in terms of Bangiya Gramin Vikash Bank (Employees') Pension regulations, 2018 read with Bangiya Gramin Vikash Bank (Employees') Pension (Amendment) Regulations, 2024 from the date of retirement or 01.11.1993 (Whichever is later)

Department of Financial Services (DFS), Ministry of Finance, Government of India vide its letter F. No. 8/20/2010-RRB dated 3rd October, 2024 forwarded the Model RRB (Employees') Pension (Amendment) Regulations, 2024 (both in Hindi & English) duly approved by the competent authority in consultation with NABARD and the Sponsor Banks under the provisions of Section 30 of the RRBs Act, 1976.

Accordingly, Hon'ble Board of Directors vide circulation on 04.10.2024 has adopted the said amendments in Bangiya Gramin Vikash Bank (Employees') Pension regulations, 2018 and ratified the same vide its 113<sup>th</sup> meeting held on 22.10.2024 and was published in Gazette of India, Extraordinary, Part-III, section 4 on 23rd October, 2024 which is now called as Bangiya Gramin Vikash Bank (Employees') Pension (Amendment) Regulations, 2024.

In terms of the said regulation and direction received from DFS in this regard, Bank is pleased to offer commutation of pension as a onetime measure to General Pensioners (who were drawing pension as on 01.04.2018) from the date of retirement or 01.11.1993, whichever is later.

Accordingly all eligible General Pensioners (as stated above) are now requested to exercise their option of commutation by following the process as noted below:

Period during which option can be submitted: **12<sup>th</sup> February 2025 to 18<sup>th</sup> February, 2025** (No further extension of date shall be entertained in this regard).

## Following points are to be noted:

- i. General Pensioners (who were drawing pension as on 01.04.2018) and had commutated their pension but died later, the respective <u>family pensioners cannot opt</u> <u>for change in commutation date.</u>
- ii. The option can be exercised by **General Pensioners only**.
- iii. General Pensioners who opts for commutation of pension from date of retirement (or from 01.11.1993, whichever is later), are eligible to get the same subject to <u>adjustment</u> <u>of recovery/realization of commuted basic from date of superannuation along</u> <u>with EPS, 1995 received (from 58 years of age to 60 years, if any) respectively.</u>
- iv. In case of non-exercising of above stated option by any eligible pensioner, <u>it shall be</u> <u>construed that the said Pensioner is not willing to avail commutation from</u> <u>retrospective date and accordingly there shall be no change in his/her</u> <u>commutation date (if any).</u>
- v. <u>General Pensioners (as noted above), who have already availed the benefit of</u> <u>"latter commutation", (i.e. retired on or before 01.04.2018 but availed</u> <u>commutation after 01.04.2018) are outside the purview of availing the same from</u> <u>retrospective date again</u>.

A copy of this circular is to be displayed in Bank's Website and Notice Board for information of all concerned and strict compliance of the same.
