- Rates are to be quoted only in the prescribed annexure attached with this Notice. 3.
- Quoted rate submitted in any other format, will be liable to cancel.
- 4. Firms must have GST registration number.
- After expiry of the above time schedule no quotation will be accepted. 5. 6.
